



1. What are Cookies?

The website of JABA I Inversiones inmobiliarias (hereinafter JABA) www.jabaholdings.com, uses cookies and other files with similar functionality. Cookies are small data files that are sent to the User's computer, mobile phone or other access device when visiting a web page and that allow to obtain information related to browsing or a code that allows the user to be uniquely identified.

2. Type of Cookies and purposes of use.

The following information will help you better understand and value our cookie policy:

According to the period of time that they remain activated:

Session Cookies: These are a type of cookies designed to collect and store data while the user accesses a Web page. They are usually used to store information that is only interesting to keep for the provision of the service requested by the user on a single occasion (eg a list of products purchased).

According to its purpose:

Technical cookies: These are those that allow the user to navigate through a Web page, platform or application and the use of the different options or services that exist in it, such as, for example, controlling traffic and data communication, identifying the session, access parts of restricted access, remember the elements that make up an order, carry out the purchase process of an order, apply for registration or participation in an event, use security elements while browsing, store content for dissemination videos or sound or share content through social networks.

Analysis cookies: These are those that allow the person responsible for them to monitor and analyze the behavior of the users of the websites to which they are linked. The information collected through this type of cookie is used to measure the activity of websites, applications or platforms and to create browsing profiles for users of said sites, applications and platforms, in order to introduce improvements in function of the analysis of the usage data made by the users of the service.

Geolocation cookies: These are those that are used to know where a user is when requesting a service. This cookie is anonymous and is used, for example, to offer you the appropriate information depending on the country in which you are.

Personalization cookies: These are those that allow the user to access the service with some predefined general characteristics based on a series of criteria in the user's terminal, such as the language, the type of browser through which the service is accessed, the regional configuration from where you access the service, etc.

Advertising cookies: These are those that allow the offer of advertising spaces on the website to be managed in the most efficient way possible, adapting the content of the advertisement to the content of the requested service or the use made of our website.

Session Cookies: These are a type of cookies designed to collect and store data while the user accesses a Web page. They are usually used to store information that is only

interesting to keep for the provision of the service requested by the user on a single occasion (eg a list of products purchased).

3. Deactivation or elimination of Cookies.

You can accept, reject or modify your preferences on the use of cookies in the following configuration panel:

Likewise, most web browsers allow you to manage, at any time, the preferences of the User regarding the use of Cookies. The User can adjust his browser so that it rejects Cookies or eliminates certain Cookies at his discretion.

4. Updates and changes in the Cookies Policy.

JABA may modify this Cookies Policy based on new legislative or regulatory requirements, or with the purpose of adapting said policy to the instructions issued by the Spanish Agency for Data Protection.

When significant changes occur in this Cookies Policy, the user will be notified by means of an informative notice on the web page.
